The successful candidate will provide advanced technical aviation insurance support to the underwriting staff. Through administrative and analytical support, the Underwriting Support Coordinator performs basic underwriting functions on new and renewal business working in tandem with underwriters, however does not have authority to bind coverage or sign policies. Duties and responsibilities include but are not limited to the following:

Position Responsibilities:

- Initiate the administrative process for the generation of certificates of insurance, endorsements, policies and other insurance documents for routine as well as complex accounts.
- Review insurance applications and follow up to request and obtain missing information as necessary.
- Research issues and analyze data as necessary. Prepare reports for underwriters and managers as requested.
- Perform basic underwriting functions on simple risks, however, does not have the authority to bind coverage or sign policies.
- Obtain senior underwriter approval for insurance documents created and issued.
- Interface with branch and Home Office personnel regarding coverage issues.
- Perform other miscellaneous administrative and underwriting support duties as assigned.

- Ability to identify data which may be non-standard with regard to underwriting guidelines and address such matters with underwriters.
