Preparing for IS-BAO or IS-BAH Audit Performance Vector Safety Program





The International Standard for Business Aviation Operations (IS-BAO) is an industry code of practice designed to help flight departments worldwide achieve a high level of safety and professionalism. In 2014, the International Business

Aviation Council (IBAC), which administers the IS-BAO, introduced the International Standard for Business Aircraft Handling (IS-BAH) to elevate the professionalism and safety focus of business aircraft handling concerns. USAIG recognizes that preparing for and undergoing an IS-BAO or IS-BAH audit fosters a proactive and systematic approach to safety, and we encourage the pursuit and attainment of these registrations. This Performance

Vector option contains three components that can support and advance preparations for a registration audit. Policyholders can *choose any two* of the three components below to customize their support package to best suit their needs:



- A. USAIG will purchase a copy of the IS-BAO or IS-BAH standard for you, making your organization a registered holder of the standard in perpetuity thereafter. *Note: holding an organizational copy of the standard is a requirement to attain IS-BAO or IS-BAH registration, but it only needs to be purchased once, after which registered holders can obtain annual updates from the International Business Aviation Council (IBAC).*
- B. SMS-Lift[™] from Convergent Performance. This group-formatted course addresses the vital SMS challenge of maximizing safety participation from all members of a flight organization. All materials are provided in a boxed kit to enable a member of your flight department to administer the course.
- C. Paid tuition for one attendee at an IS-BAO or IS-BAH workshop as a non-accredited attendee (travel and lodging are not covered). *Note: policyholders can opt to receive two paid workshop tuitions as their two components of this offer if that is preferable to options A or B.*
